Consequent to Hon'ble High Court of Uttarakhand, Nainital judgment no.WPSS 2048 of 2016 dated 28/03/2017 (Annexure: BoG 20.04), Mr. Manoj Kumar was appointed as Junior Assistant in the Institute, vide Office Order No.NITUK/Estt./2017/Recruitment/034/A-397 dated 16/08/2017 (Annexure: BoG 20.05), under OBC category through deliberations in the Board vide BoG 13.13(a) dated 27th June, 2017 and BoG 14.16 dated 6th December, 2017 (Annexure: BoG 20.06). He joined the Institute on 21/08/2017.

As per the same judgment, Mr. Manoj Kumar was also supposed to be granted all consequential benefits, at par with other appointees, appointed against the same recruitment vide Advertisement No.1/2014 dated 24/08/2014, of which the appointment order was issued vide no.NITUK/Estt./2014/Recruitment/034/1901 dated 17/10/2014 (Annexure: BoG 20.07). Consequentially, Mr. Manoj Kumar should have been issue an appointment order on 17/10/2014. As per Board resolution no. BoG 04.06 dated 15/11/2013 (Annexure: BoG 20.11), Deputy Registrar (Accounts)/Assistant Registrar (Accounts) was designated as authorized signatory for Institute Principal Accounts Officer (Pr.AO), Pay and Accounts Officer (PAO), Drawing and Disbursing Officer (DDO) and Cheque Draining and Disbursing Officer (CDDO). The Registrar has joined the Institute since 2015, therefore, Registrar may now be designated as authorized signatory as Pr.AO and DDO, whereas, Deputy Registrar (Accounts) /Assistant Registrar (Accounts) shall continue to be designated as authorized signatory for PAO and CDDO.

The Board is requested to approve the above proposal.

BoG 20.09: Protection of Pay and Seniority of Dr. Vikas Pratap Singh (Employee Code: 189/118146), Assistant Professor (Grade-I), Department of Civil Engineering.

Dr. Vikas Pratap Singh was appointed as Assistant Professor (Grade-I, AGP ₹8000/-) in the Department of Civil Engineering vide Appointment Order No.A-225 dated 11/06/2018 (Annexure: BoG 20.12). He joined the Institute on 28/06/2018.

Dr. Vikas Pratap Singh has submitted an application dated 30/07/2018 to claim the protection of pay and seniority (Annexure: BoG 20.13). The brief of the case, as per the records made available to the Institute, is as follows:

- a) He was appointed as Assistant Professor (Grade-II, AGP ₹7000/-) in NIT Patna on 29/07/2015, where he served till 26/12/2015 in the same AGP.
- b) Thereafter, he was appointed as Assistant Professor (AGP ₹8000/-) in IITRM, Institute of Infrastructure Technology Research and Management, Ahmedabad (An Autonomous Institute under Govt. of Gujarat) on 29/12/2015 and his Basic Pay was fixed at ₹41,530/- (Pay ₹33,530/- plus AGP of ₹8000/-), where he served till 27/06/2018 in the same AGP.
- c) He joined NIT Uttarakhand on 28/06/2018 as Assistant Professor (Grade-I, AGP ₹8000/-) after completing technical formalities at IITRM, Ahmedabad in 7th CPC, Basic Pay of ₹1,01,500/- [Pay Matrix: 12(1)] which, in 6th CPC is equivalent to Basic Pay of ₹38,000/- (Pay: ₹30,000/- plus ₹8000/-).
- d) Basic Pay: His last drawn Basic Pay at IITRM, Ahmedabad was ₹44,070/-(Pay: ₹36,070/- plus AGP: ₹8000/-) in 6th CPC. Para 2.4 of DOPT OM No.28020/1/2010-Estt.(C) dated 17/08/2016 (Annexure: BoG 20.14) stipulates:

"2.4 Pay Protection, eligibility of past service for reckoning of the minimum period for grant of Annual Increment.

"In cases of appointment of a Government servant to another post in Government on acceptance of technical resignation, the protection of pay is given in terms of the Ministry of Finance OM No.3379-E.III (B)/65 dated the 17th June, 1965 read with proviso to FR 22-B. Thus, if the pay fixed in the new post is less than his pay in the post he holds substantively, he will draw the presumptive pay of the pay he holds substantively as define in FR-9(24). Past service rendered by such a Government servant is taken into account for reckoning of the minimum period for grant of annual increment in the new post/service/cadre in Government under the provisions of FR 26 read with Rule 10 of CCS (RP) Rules, 2016. In case the Government servant rejoins his earlier posts, he will be entitled to increments for the period of his absence from that post."

In the light of above, pay of Dr. Vikas Pratap Singh may be protected as ₹44,070/-(Pay: ₹36,070/- plus AGP: ₹8000/-) as per 6th CPC and accordingly be fixed at 7th CPC in the Pay Matrix Level: 12(6) – ₹1,17,500/- which includes one Annual Increment w.e.f. 01/07/2018, honoring the past service for reckoning the minimum period for grant of Annual Increment.

As per Para 2.6 of DOPT OM No.28020/1/2010-Estt.(C) dated 17/08/2016 stipulates:

"2.6 Seniority: On technical resignation, seniority in the post held by the Government servant on substantive basis continues to be protected. However, in case of a Government servant deciding to rejoin his substantive post, the period spent in another department which he had joined after submitting his technical resignation will not count for minimum qualifying service for promotion in the higher post."

In the light of above, the seniority of Dr. Vikas Pratap Singh in AGP ₹8000/continues to be protected from 29/12/2015.

The Board is requested to grant protection of pay to Dr. Vikas Pratap Singh, with fixation at ₹1,14,100/- as on 28/06/2018 and one annual increment from 01/07/2018. His seniority in the Institute, in AGP of ₹8000/-, continues to be protected from 29/12/2015.

BoG 20.10: Approval of the draft Annual Report for the financial year 2017-18.

A draft Annual Report for the financial year 2017-18 is prepared and enclosed as **Annexure: BoG 20.15**.

The Board is requested to approve the Annual Report for the financial year 17-18.

BoG 20.11: Entitlement of Travelling Allowance, Daily Allowance and Sitting Fees to the Members of the Authorities of the Institute for attending the meetings of the Authorities and their Committees.

In accordance the Section 15 of NIT Statutes which stipulates that

"15. TRAVELLING ALLOWANCES OF MEMBERS OF THE AUTHORITIES OF INSTITUTE.

"Members of the Board and other authorities of the Institute and members of the Committee constituted under the Act or these Statutes or appointed by the Board and other authorities shall be entitled to travelling allowance, daily allowance and sitting fee for attending the meeting of the authorities and their Committees as laid down by the Board from time to time".

As per Section 10 of NIT Act and Section 3 of NIT Statutes, BoG, Senate, FC and BWC are the authorities of the Institute. The Section 11, 14 & 18(2) of NIT Act and Section 10, 12, 23 (5) (a) (b) (c) (d) & 23 (18) of NIT Statutes, delineates the members of the respective Authorities of the Institute.

As per the provisions of Section 15 of NIT Statutes, all the members of the Board, Senate, FC, BWC and other authorities of the Institute and members of the Committee constituted under the Act or these Statutes or appointed by the Board and other authorities shall be entitled to Travelling Allowance, Daily Allowance and Sitting Fee for attending the meeting of the authorities and their Committees.

The Board is requested to approve the above proposal w.e.f. 21.07.2017, [i.e. the date of issue of clarification through Office Memorandum of MHRD vide no.F.No.33-5/2016-TS.III dated 21st July, 2017 (Annexure: BoG 20.16)], as per the provisions of Section 10 of NIT Act, Section 3 of NIT Statutes, Section 11, 14 & 18(2) of NIT Act and Section 10, 12, 23 (5) (a) (b) (c) (d) & 23 (18) of NIT Statutes, and shall be applicable to all other statutory committees composed with the approval of BoG/Senate/FC/BWC.

BoG 20.12: Action on CBI self-contained note No.PE007214A0006 dated 24/09/2015 against Mr. Kumar Gauray.

Further to the Board resolution no. BoG 13.08, the Interim CVO of the Institute examined the case and forwarded its report to Central Vigilance Commission (CVC) for First Stage Advice vide letter dated 8th February, 2018. In response to this, a letter has been received from MHRD vide letter no.F.No.30-2/2016.TS-III dated 6th June, 2018, the same is placed as **Annexure: BoG 20.17** alongwith the covering letter of the Interim CVO of the Institute.

Consequent to Mr. Kumar Gaurav not completing his Ph.D. in the stipulated period of contract, his services were terminated w.e.f. 13th March, 2018 vide Board resolution no. BoG 16.03 (i), therefore, he is no more employee of the Institute (Annexure: BoG 20.18).

Since, Mr. Kumar Gaurav has been relieved from the Institute, the Board is requested to deliberate upon and issue necessary directions.

BoG 20.13: Extension of contract of service of Mr. Maheep Singh and Mr. Mahiraj Singh Rawat.

Mr. Maheep Singh was appointed as an Assistant Professor on contract, Department of Computer Science & Engineering vide office order no.NITUK/ESTT/2013/549 dated 07/06/2013, on the basis of M.Tech. qualification. His appointment was approved by the BoG vide Agenda Item No.02.07 in 2nd BoG meeting held on 25/02/2013. He joined the Institute on 05/07/2013 and signed the service contract agreement on 24th July, 2013 for a period of five years i.e. upto 04/07/2018. He was expected to complete Ph.D. within the contract period, but he was unable to fulfill the service contract requirement of completing the Ph.D. within the contract period.

As per his request for extension of service contract dated 28/11/2017, the BoG vide Agenda Item No. BoG 17.04, granted him one time extension of service contract upto 31/12/2018, as a special case. He was expected to complete Ph.D. within the extended contract period, but he is still unable to fulfill the service contract requirement of completing the Ph.D. even within the extended contract period.

However, he has produced a certificate dated 31/12/2018 from the Associate Dean (PG & Ph.D), MNIT Jaipur stating that **he has submitted Ph.D. Thesis on 31/12/2018** with a request vide letter dated 16/12/2018 for extension of contract till award of Ph.D. The contract of Mr. Maheep Singh is expiring on 31/12/2018. The issue of grant of extension can only be considered by the BoG, the meeting of which is to be held in the month of Jaunary-2019. Therefore, the Chairman, BoG, in accordance with the provision of the NIT Statutes 17(15), granted permission to extend the contract of service of Mr. Maheep Singh till the day of consideration of his request by the BoG and confirmation of the minutes there upon (Annexure: BoG 20.19).

Mr. Mahiraj Singh Rawat was appointed as an Assistant Professor on contract, Department of Electrical Engineering vide office order no.NITUK/ESTT/2013/549 dated 07/06/2013, on the basis of M.Tech. qualification. His appointment was approved by the BoG vide Agenda Item No.02.07 in 2nd BoG meeting held on 25/02/2013. He joined the Institute on 01/07/2013 and signed the service contract agreement on 2nd day of July, 2013 for a period of five years i.e. upto 30/06/2018. He was expected to complete Ph.D. within the contract period, but he was unable to fulfill the service contract requirement of completing the Ph.D. within the contract period.

As per his request for extension of service contract dated 27/11/2017, the BoG vide Agenda Item No. BoG 17.04, granted him one time extension of service contract upto 31/12/2018, as a special case. He was expected to complete Ph.D. within the extended contract period, but he is still unable to fulfill the service contract requirement of completing the Ph.D. even within the extended contract period.

However, he has produced a certificate dated 28/12/2018 from the Dean (Academic), NIT Kurukshetra stating that he has submitted Ph.D. Thesis on 20/12/2018 with a request vide letter dated 21/12/2018 for extension of one more year for completion of Ph.D. defence seminar.
