The above faculty members was placed under probation period of one year from the date of acquiring Ph.D. Degree and has successfully completed the probation as per detailed mentioned above. Dr. Deepak Kumar joined the Institute on 11/07/2014 as Trainee Teacher under the Trainee Teacher Scheme on the basis of B.Tech. qualification. "The Performance Review Committee unanimously recommended that Dr. Deepak Kumar shall be absorbed as Assistant Professor, Department of Mechanical Engineering w.e.f 09.06.2021 (Ph.D thesis defended date) with one year of probation period".

BoG 37.05: Regularization of services on completion of Ph.D. of Dr. Rohit Kumar, Trainee Teacher, Department of Electrical Engineering.

Dr. Rohit Kumar joined the Institute on 03/07/2015 as Trainee Teacher under the Trainee Teacher Scheme on the basis of B.Tech. qualification. He was deputed for M.Tech./Ph.D. course work at IIT Roorkee for a period of one year w.e.f. 23/07/2015 vide Office Order No.A-232 dated 23/07/2015 and acquired the Ph.D. Degree on 12/10/2021.

As per clause no.4 of contract agreement dated 11/07/2015 signed between Dr. Rohit Kumar and Director, NIT Uttarakhand, On completion of Ph.D., the Party No. 1 will be required to appear before the duly constituted committee as applicable for recruitment of faculty and provided that recommendation of the committee are accepted by the BoG for placing in another contract as Assistant Professor (on contract). All the rules of Institute regarding appointment of Assistant Professor shall be applied to Trainee Teacher.

As per Trainee Teachers Scheme notified by the Ministry of HRD vide letter no. F.23-12/2009-TS.III (Pt.) dated 22/03/2013, “on successful completion of Ph.D. Programme within stipulated period, the Trainee Teacher will be absorbed as an Assistant Professor in that NIT in regular scale with all associated benefits and services rendered as trainee will be counted for various benefits admissible to employees of NITs.”

The Institute has also carried out Performance Review of the Dr. Rohit Kumar through duly Constituted Committee of Experts and recommendation of the committee is as under:

“The Performance Review Committee interacted with Dr. Rohit Kumar and assessed the performance of Dr. Rohit Kumar on the basis of his knowledge, research and future plans. Since, Mr. Amardeep submitted his Ph.d. thesis on 28.07.2021 and his contract was going to end on 30.07.2021. BoG 37.07: Approval for Professional Development Fund (PDF) to Trainee Teachers.

The Finance Committee vide item no. FC 14.02 resolved that Professional Development Fund (PDF) may be paid to the Trainee Teachers prospectively as per the rates mentioned in the Trainee Teachers Scheme. Reimbursement will be only

for membership of Professional societies, attending conferences, publication of papers and procurement of books related to relevant field.

As per Trainee Teachers scheme, 10% of Gross salary shall be eligible towards contingency/professional expenditure. Accordingly, 10% of Gross salary for the Financial Year 2020-21 computed towards the Professional Development Fund (PDF) of Trainee Teachers for the Financial Year 2021-22 as follows:

Therefore, Board is requested to approve the Professional Development Fund (PDF) as per above details.

BoG 37.08: Regarding technical resignation from the post of Assistant Professor (Gr-I), Dept. of Civil Engineering and retention of lien i.r.o. Dr. Vikas Pratap Singh.

Consequent upon selection of Dr. Vikas Pratap Singh, Assistant Professor (Gr-I), Dept. of Civil Engineering in the Netaji Subhas University of Technology (NSUT), New Delhi as Associate Professor in the Dept. of Civil Engineering in the Pay Level-13A (Pay Matrix 1,31,400-2,17,100). Accordingly, a technical resignation is received from Dr. Vikas Pratap Singh vide inward No.2690 dated 18/11/2021 and requested to relieve him on 14/12/2021 with retention of lien. Related documents are enclosed as (Annexure BoG 37.04).

As per the section 24 (vii) of NIT Statutes, Dr. Vikas Pratap Singh was issued No Objection Certificate (NOC) vide letter no.977 dated 01/11/2021.

The Board of Governors has approved the Lien to the Institute employees vide agenda item no.BoG 13.04 dated 27/06/2017, as per DOPT, Govt. of India norms. Accordingly, as per Fundamental Rules 9(13), it represents the right of a Government employee to hold a regular post, whether permanent or temporary, either immediately or on the termination of the period of absence. The benefit of having a lien in a post/service/cadre is enjoyed by all employees who are confirmed in the post/service/cadre of entry.

As per Point No.3.3(i) of DOPT OM No.28020/1/2010-Estt.(C) dated 17/08/2016, "A permanent Government servant appointed in another Central Government Department/Office/State Government, has to resign from his parent department unless he reverts to that department within a period of 2 years, or 3 years in exceptional cases. An undertaking to abide by this condition may be taken from him at the time of forwarding of his application to other departments/office". Copy of undertaking enclosed alongside.

Dr. Vikas Pratap Singh has been confirmed on the post of Assistant Profssor (Gr-I), Dept. of Civil Engineering with retrospective effect from 27/06/2019 vide Office Order No.A-1011 dated 22/11/2019.

Therefore, technical resignation with request of lien of Dr. Vikas Pratap Singh is hereby placed for the approval of the Board.

BoG 37.09: Regarding Nursing Allowance.

Nurse was appointed in the Institute in the year 2016 who is looking after the Dispensary of the Institute under supervision of Coordinator Medical Service. At there is no provision of Nursing Allowance to the staff working in Institute Dispensary. However, as per OM Z.28015/50/2017-N dt.31.08.2017 issued by Government of India, Ministry of Health and Family Welfare Finance (Nursing Section) (copy enclosed). Nursing Allowance is admissible to all Nurses whether working in Dispensaries or in Hospitals.

BoG 37.10: Permission regarding Designing, Development and Hosting of Bilingual Institute Website.

Institute website is presently running on old CSS style of coding and unstructured database functionality. Beside this security audit of website is also not done till date. To prevent the website from any kind of cyber-attack, there is an immediate need of redesign the Institute website on new CSS style or frameworks and security audit as per Guidelines for Indian Government Websites (GIGW) and other government guidelines.

For designing & development of Bilingual (English & Hindi) Institute Website, the tentative expenditure incurred including 03 Years maintenance and Warranty along with Hosting are as follows:

BoG 37.11: To consider the Institute Intellectual Property Rights (IPR) Policy.

The IPR cell, NIT Uttarakhand under R&C section has drafted Institute first IPR policy for the management of intellectual property right to facilitate, encourage, promote and safeguard scientific investigation and research and the freedom of the faculties/staff and scholars involved in R&C activities. The policy is drafted keeping in view of the "Model Guidelines on Implementation of IPR Policy for Academic Institutions" by Deptt. for Promotion of Industry and Internal Trade (DPIIT); Ministry of Commerce & Industry and IPR policies of other IITs/NITs. The said draft has been recommended by Deans and HODs committees after incorporating the suggestions and duly approved by the Competent Authority. The final draft of the IPR Policy is enclosed as (Annexure BoG 37.05).

The Board is requested to kindly consider the draft and approve the same for the implementation in the Institute.

BoG 37.12: Permission for availing Helicopter services from Pawan Hans Limited to dignitaries, experts & external member of the committee.

NIT Uttarakhand has recently signed an MOU with Pawan Hans Ltd. Presently Pawan Hans limited is operating helicopter service from Srinagar Garhwal to Dehradun airport (to and fro) at affordable cost.

Therefore, it is proposed that Helicopter services from Pawan Hans Limited to dignitaries, experts & external member of the committee invited by the Institute may be extended.

Board is requested to deliberate upon the matter.
