It is kindly brought to the notice of the Hon'ble Board members that in the past five years nine Trainee Teachers have resigned and relieved from the Institute pre-maturely. Whereas, Institute had regularly reimbursed the Tuition Fees to support their M.Tech./Ph.D. programme, with the hope that they will continue and complete their Ph.D. and serve the Institute for a minimum of three years as faculty, after completing Ph.D. Their pre-mature resignation has resulted into loss of the funds invested toward promoting their education.

Hence, it is proposed to recover the full Tuition fees paid to the Trainee Teachers, if he pre-maturely resigns from the Institute.

The Finance Committee is requested to deliberated upon and issue the necessary instructions in this regard, please.

Resolution: Withdrawn.

FC 19.05: Approval of Seed Money Grant to Faculty for research purpose.

A meeting of the faculty with the Hon'ble Director resolved that to promote the research work and to create conducive research environment in the Institute, it is proposed to sanction a Seed Money Grant of Rs.4.00 Lakhs to each faculty members, having Ph.D. Degree and having served the Institute for a period of 2 years. The Minutes of the meeting with the Hon'ble Director are enclosed as Annexure FC 19.02.

The Finance Committee is requested to approve the Grant of Seed Money of Rs.4.00 Lakhs to eligible faculty members of the Institute.

Resolution: Finance Committee recommends grant of Seed Money to the maximum upto Rs.5.00/- to Regular eligible faculty members. The Director shall constitute a Project Evaluation Committee with subject experts from IITs to evaluate and recommend the amount of Seed Money to be granted for a project proposal. The details of the approved project proposal, duly recommended by the Project Evaluation Committee shall be placed before the Finance Committee for a information.

FC 19.06: Status of Procurement activities under TEQIP-III project.

Institute had submitted total 43 Nos. of Packages of estimated cost Rs.803.00 Lakhs on PMSS out of the approved Institute Procurement Plan (IPP) which was also

approved by the NPIU on 25/04/2019. The sanctioned Budget under Goods is Rs.825.00 Lakhs and in the above submitted packages ERP software is not considered. The details of the submitted Packages are presented in Annexure: FC 19.03. Out of these 43 Nos. of Packages, total 28 Nos. of Packages of estimated cost Rs.500.25 Lakhs has been initiated for procurement till date as per the guidelines of NPIU and its Procurement Manual. The brief details of these initiated Packages are as follows:

a) One Package (Optisystem V15.1 or latest) of worth Rs.7, 98,000/- (Rupees Seven Lakh Ninety Eight Thousand Only) is supplied against the Purchase Order issued on 06.09.2019.

b) Total 03 Nos. of Supply Orders have been issued to the Vendors of worth Rs.30,03,000/-(Rupees Thirty Lakh Three Thousand Only).

- c) Total 04 Nos. of Packages of worth Rs.29,82,180/-(Rupees Twenty Nine Lakh Eighty Two Thousand One Hundred Eighty only) is in process of issuing the Purchase Order.
- d) Total 15 Nos. of Packages of estimated cost Rs.388.20 Lakh (Rupees Three Crore Eighty Eight Lakh Twenty Thousand only) are in process after opening of the Quotation Invitation.

e) Total 03 Nos. of Packages are in process of cancellation after opening/receiving the Quotations.

f) Total 02 Nos. of Packages have been cancelled.

The status of all the submitted packages till date is described in Annexure: FC 19.03.

The above mentioned Status of Procurement activities under TEQIP-III project is submitted for kind information of the Finance Committee and instructions if any.

FC 19.07: Revision in the approved Institute Procurement Plan of TEQIP-III project.

In view of the current status of the procurement of equipment and requirements, Institute Level Purchase Committee recommended the revised plan for the remaining estimated budget of Rs. 286.50 Lakh (Rupees Two Crore Eighty Six Lakh & Fifty Thousand Only), under procurement of Goods. This is calculated on the basis of revised total allocated budget September 2019 i.e. Rs.1350 Lakh (Rupees Thirteen Crore Fifty Lakh) after deducting the 10% of the total budget as per performance review of NPIU. In this revised plan, the budget of ERP has not been included as the details of its estimated cost and procedure of payment has not been finalized till date by the NPIU. The details of the proposed packages, their quantity and estimated cost mentioned in the revised Institute Procurement Plan (Annexure: FC 19.04). The budget proposed in the revised procurement plan 2019 is based on the estimated cost of the items and considering the probability of execution of procurement of the initiated/proposed Packages.

Excellence in teaching and research essentially requires the state-of-the-art sophisticated equipment's, and support facilities which can facilitate the faculty, research scholars and students to carry out globally competitive interdisciplinary R&D in basic and applied sciences as well as engineering. The Minutes of the HoDs meeting in this regard are enclosed as **Annexure: FC 19.05.** 

NIT Uttarakhand, being a new NIT, desperately requires a Central Instrumentation Facility (CIF) with a mission to enrich the resources on a shared basis for promoting Research and Consultancy and to strengthen technological infrastructure leading to improve the NIRF ranking. In the First Phase of developing the Centralize Instrumentation Facility the focus will be primarily on **Testing & Material Characterization** as well as **Nanotechnology** based Instruments listed below with their estimated cost of Rs.1,055/- Lakhs.

Institute has essentially required a High Speed Camera to carry out experimental and research work for M.Tech. students, Ph.D. students and faculty members. High Speed Camera essentially captures several important phenomenon such as boiling (bubble dynamics), flow through micro channel, crack propagation, neck formation, breaking phenomenon during material testing and various modes of vibration. Moreover, it can also be used for interdisciplinary research work.

Hence, Finance Committee is requested to approve the estimated amount of Rs.19,00,000/- for the purchase of High Speed Camera.

FC 19.13: TA/DA guidelines for the Institute.

With reference to the TA/DA guidelines of the TEQIP III in respect of travel by Taxi "At places where no specific rates have been given either by directorate of transport of the concerned state or the neighboring state" the rates shall be:

For Journey performed in own car/taxi =₹24/- per km. For journey performed by auto rickshaw own Scooter, etc. = ₹12/- per km.

Uttarakhand state transport has defined the rates as ₹10/- per km for own car and ₹13/- per km for Taxi. Due to hilly terrain and tourist influx these rates are not meeting the actual expenses which are charged by Taxi operators/unions. As per the directions of the Finance Committee vide Agenda FC 17.05 communication was done with SPIU Dehradun and they have given their consent for enhanced road

mileage rates subjected to approval by the respective Finance Committee/ Board of Governors.

Therefore, it is proposed to allow travel rates especially for hilly terrain as follows:

For Journey performed by Taxi = ₹24/- per km For journey performed by own car = ₹12/- per km

FC 19.14: Grant of Honorarium to Non-Teaching staff members for additional responsibilities entrusted.

NIT Uttarakhand is having acute shortage of Officers as well as Higher and Lower Ministerial staff to manage the work load in the sections namely Establishment, Accounts, Stores, Academics, Hostels, Library, Sports, Director's Office, Registrar's Office, Training & Placement Cell, Recruitment Cell, RTI Cell, Legal/Grievance Cell and various projects etc. The staff members are entrusted with additional charge/responsibilities for which it is felt that some honorarium should be paid to them as compensation for the same.

The remoteness of the Institute also affects the functioning of the above mentioned sections adversely, as trained and skilled manpower is not available on contractual basis. As a result, the work load of the regular employees gets enhanced.

To honor then for holding additional charge/work load and responsibilities, it is proposed to grant monthly honorarium to such non-teaching staff members those who are given additional engagements:
