Regarding approval of seat matrix for the Academic Year 2021-2022 onward.

In compliance to the MHRD letter No. F.No.35-4/2019-TS.III dated 19th June, 2019, the intake of UG students was reduced to 100 for Academic Year 2019-2020 which was later on approved vide resolution of Agenda BoG 22.16 of 22ndBoG dated 22nd June, 2019. However, it was also proposed that the number of students in the institute during 2020-2021 may be worked out in such a way that the institute is able to provide proper infrastructural and other necessary facilities to the admitted students while ensuring fulfilment of constitutional obligation w.r.t. EWS reservations. A maximum of 800 students vide MHRD Letter No DO F.No. 33-1/2012.TS-III (Annexure S 28.02A) and 1260 students vide MHRD Letter No. F.No.30-3/2019.TS-III (AnnexureS 28.02B) canbe accommodated in the Srinagar and Sumari campus of NIT Uttarakhand, respectively. This special Ordinance is proposed in the interest of the Institute and continuing the education in an unprecedented situation without diluting the teaching, learning and evaluation processand covers all deviation from the established Rules and Ordinances.

In case the COVID-19 subsides, and instructions of MHA, Gol issued subsequently, students may return back in the campus in between the running Semester (i.e. ODD Semester, 2021), the Teaching, Learning and Examinations process shall be resumed in-campus, as per the existing Ordinance.
