

A letter has been received from Ministry of Education vide F.No. 33-3/2022-TS.III dated 28th December, 2022 regarding applicability of payment of gratuity Act, 1972 to educational institutions under the Ministry of Education **(Annexure BoG 44.05)** for taking necessary action in respect of Office Memorandum No.F.No.15-2/2022-TC dated 16th December, 2022 and others OMs.

It is to submit that as per the NIT Statutes clause no.29 "Employees of the Institute appointed prior to 1.1.2004 will be governed by Central Civil Services (Pension) Rules, 1972 and Central provident Fund (Central Services) Rules, 1960 and the Employees appointed on or after 1.1.2004 will be governed by New Pension

Scheme of Central Government".

The Institute is established in 2009 and presently all the employees of the Institute are covered under New Pension Scheme of Central Government. As per New Pension Scheme of the Central Government, gratuity is admissible under Central Civil Services (Pension) Rules, 1972.

As per OM F.No. 1(16)/EV/2017 dated 02.12.2021 of Ministry of Finance, the applicability of CCS (NPS) Rules, 2021 to the employees of CABs is under consideration.

The Board is requested to adopt the Payment of Gratuity Act 1972 for the employees of the Institute appointed after 1.1.2004, till the directions of Ministry of Finance regarding applicability of CCS (NPS) Rules, 2021 to the employees of CABs is received.

As per the resolution of the Board in its 40th meeting vide agenda item no. BoG 40.15; "Board approves the extension of services of above mentioned faculty members for a period of six months or till the completion of recruitment proves

BoG 44.16: Re-allocation and Transfer of Fund under Budget Heads.

With reference to SAR audit report (point no. B.2) for the year 2021-22, it is noted that as per Annual Accounts format for Central Higher Education Institutions, the accounting of Consultancy & Professional charges should be booked under the head "Administrative and General Expenses (Schedule 17)" instead of "Establishment Expenses (Schedule 15)" enclosed as **(Annexure BoG 44.12)**.

The accounting of Consultancy & Professional charges has been booked under the head of Establishment Expenses (Schedule 15) in accordance with the heads approved in budget estimates.

It is proposed to re-allocate the head of Consultancy & Professional charges in approved budget estimates from Establishment Expenses head to Administrative and General Expenses head as per Schedule 17 of Annual Accounts format and audit observation.

Also, due to relieving of few faculty members mid academic year leads to requirement of Adhoc Faculty which in turn leads to shortage of fund under the budget head "Pay of Teaching staff (Contract), OH 31.05".

It is proposed to transfer Rs. 5 Lakh from budget head "Consultancy & Professional Charges, OH 31.06" to budget head "Pay of Teaching staff (Contract), OH 31.05" required for hiring of Temporary Faculty. No financial impact of above changes will be there in the approved total Budget Estimates for the year 2022-23.

The Board is requested to approve the above changes.

BoG 44.17: Regarding redistribution of M.Tech. seats.

As per approval of Senate, 95 seats were approved for M.Tech. admission through CCMT. Keeping in view the less number of admissions in M.Tech. Programme (54 admission in Year 2020, 22 admissions in Year 2021 and 17 admission in year 2022), data for three Academic Years (i.e. 2019-20; 2020-2021 and 2021-2022) was reviewed by HoDs and Deans and it was proposed to discontinue some of the specialization of the Departments in which admission are NIL or less. Accordingly, revised allocation proposed by HoDs and Deans is as under:

Senate of the Institute has already approved the above mentioned distribution in its 34th meeting vide agenda item no. S.34.12. Copy enclosed as **(Annexure BoG 44.04)**. Therefore, Board is requested to approve the recommendation of Senate regarding redistribution of seats for M.Tech Programme for Academic Year 2023-24.

BoG 44.18 Approval of the Remuneration of the Temporary Faculty.

As per the approval of BoG Agenda vide item no 40.21, remuneration for temporary faculty enhanced from Rs.39,000 to Rs.70,000 per month. Due to the remote location of the Institute and the short duration of appointment (i.e. one semester), Institute finds difficulty in engaging the temporary faculty for engaging the courses. In this regard, a meeting of Deans of the Institute held to deliberate the matter **(Annexure BoG 44.13)** and recommend the followings:

- 1) Candidates with Master's degree in Engineering may be considered for temporary

faculty in Engineering. The candidates need to have first class (60% marks or (CGPA 6.5/10) at both bachelor's and master's level.

- 2) Candidates with Ph.D may be paid a remuneration of Rs.70,000/- per month as per the approval of BoG Agenda vide item no 40.21.
- 3) Candidates with Master's degree in Engineering may be paid a remuneration of Rs.45,000/- per month.

The Board is requested to approve the above recommendations.

BoG 44.19: Approval on the revised Annual Procurement Plan (APP) (2022-2023).

Total 141 degree recipients attended the ceremony in person and received the degree at the venue.

The NITs Non-Teaching Recruitment Rules 2019 were notified by the MoE vide Letter No. F. 35-5/2018-TS.III dated 04.04.2019. The same were adopted by the Board of Governors of the Institute in its 22nd meeting vide agenda item BoG 22.04 (Annexure BoG 44.16).

The point number 6 of the recruitment rules states that

“Other conditions of service: The other conditions of service of the non-teaching official for which no specific provisions have been made in these rules shall be regulated in accordance with such rules as are, from time to time, applicable as per the First Statutes of the NITs and the subsequent amendments. For matters not covered by the Statutes, the corresponding Central Government Rules shall be applicable.”

As per clause 23 sub clause 17 of the NIT Statutes *“the applications of the employees eligible for the promotion under Assured Career Progression (ACP) shall be considered by the Departmental Promotion Committee before any promotion or up-gradation is recommended.”*

The Assured Career Progression (ACP) scheme has been replaced by Modified Assured Career Progression (MACP) by the Central Government.

It is proposed that financial up gradation may be granted to employees of the

Institute under Modified Assured Career Progression (MACP) as per MACP rules.

The Board is requested to extend the benefits of the Modified Assured Career Progression (MACP) to the employees of the Institute as per MACP rules of DoPT.

BoG 44.22: Approval of the honorarium for Authorized Medical Attendant.

Institute has advertised for the post of Medical Officer several times but suitable candidate was not found. Presently Institute has advertised the post of Medical Officer vide Advt. No. 07/2022 and recruitment process is in progress.

The post of Medical officer is vacant presently and students as well as employees of the Institute are facing problems regarding consultation and treatment. As per the resolution of the 4th meeting of the Finance Committee, Director is authorized to nominate a Government (State/Central) Medical Officer to certify the bills for which suitable honoraria shall be paid.

It is proposed that a Government (State/Central) doctor may be allowed to be engaged to serve as the Authorized Medical Officer for one hour per day in the Institute dispensary, till the appointment of regular medical officer of the Institute. An honorarium of Rs. 1000 per day shall be paid to the doctor for consultation and verifications of the medical bills including transportation charges.

The Board is requested to approve the proposal.

BoG 44.23: To Consider appointment of Professor of Practice.

The National Educational Policy 2020 seeks to transform higher education by focusing on skill based education to meet needs of industry and economy. The leading Academic Institute around the world have appointed Professor of Practice to get benefit of business leaders, industry experts and R&D experts to enrich the experience of students by bringing a deep understanding and appreciation of the best practices and to meet NEP 2020 objectives.

It is proposed to consider 10 % of existing sanctioned teaching post for the appointment of Professor of Practice amongst business leaders, industry experts and R&D experts. Presently Institute is running with nine departments so one Professor of Practice in each department may be appointed, which is under the 10% limit of total teaching sanctioned post i.e. 86. The procedure and norms of IIT Roorkee for appointment of Professor of Practice need to be adopted (**Annexure BoG 44.17**).

The Board is requested to approve the proposal.

BoG 43.24: Adoption of DOE order No. F.4/1/2022 dated 21/06/2022 for MII relaxation.

As per Office Memorandum No. F.4/1/2022 dated 21/06/2022, Department of Expenditure (DOE), Govt. of India, a relaxation from the Global Tender Enquiry (GTE) under Rule 161(iv) of General Financial Rules (GFRs) 2017 has been provided that enables the relaxation on Make in India (MII) preference for 371 Equipment/Instruments/Items (**Annexure BoG 44.18-A**). The said DOE order also relaxes the MII preference provided in the DOE order no. F.12/17/2019 dated 28/05/2020, auto uploaded on GeM Portal (**Annexure BoG 44.18-B**).

Hence, it is proposed to adopt office memorandum F.4/1/2022 dated 21/06/2022 for MII relaxation.

The Board is requested to approve the proposal.

BoG 43.25: Approval for consideration of working experience of serving faculty members at NIT Uttarakhand in the ongoing and future recruitment drives.

"A" = (As per point no 7, the clarification on "Institution of repute", (MoE letter vide Ref. No. F.No.33-9/2011-TS.III dated 16/04/2019), experience shall be considered if acquired in any of the following institutions:

- a) Fully funded Central Educational Institutions.*
- b) IIMs and other Management Institutions ranked by NIRF up to 50 for any two years.*
- c) State Educational Institutions funded by respective State Government.*
- d) Other Educational Institutions ranked by NIRF up to 100 in overall, in Universities or Engineering Institutions category for any two years.*

However, with regard to recommendation on the Institution of Repute, the BoGs of the respective institutes may take a call on relaxing the criteria, if needed, with recorded justification.

There are some faculty members in the Institute recruited before 2019 having working experiences from private universities/institutes within India and universities from abroad as per the prevalent recruitment rules. As per the clarification on the institution of repute, issued in 2019 (MoE letter vide Ref. No. F.No.33-9/2011-TS.III dated 16/04/2019), their previous experiences might not be considered in the on-going and future recruitment drives due to "A" institutions above. These faculty members have contributed a lot to the growth of the institute by receiving research grants, publishing high-impact research papers and performing several administrative responsibilities at the department and the Institute levels. They have satisfied all the advertised criteria and earned more cumulative essential credit points than the minimum required as per the advertisement.

Considering the above facts of such faculty members recruited before 2019, it is proposed that their previous experiences from not "A" institutions above may be considered in the on-going and future recruitment drives.

Board is requested to deliberate upon the matter and to issue necessary directions, please.

BoG 43.26: To note the progress of Construction Activities at NIT Uttarakhand.

(i) Status of construction work of Phase – I – NIT Uttarakhand Srinagar Campus

As per the mutually agreed time schedule, the construction work was to be completed by 31.07.2021. A revised programme chart was submitted by CPWD mentioning that work shall be completed by 31.12.2021, but till Dec., 2022 only 72% physical progress was achieved by the agency.

(ii) Status of construction work of Phase – II – NIT Uttarakhand – Srinagar Campus

MoU for the construction and site development of residential and non-residential buildings was signed with CPWD on 29th August 2020. Building and works committee vide its resolution item no 16.06 has authorized ILPMC to approve the conceptual drawings and master plan for work construction phase-II. The conceptual drawings and master plans submitted by CPWD have been approved

on 29.08.2022 and CPWD was requested to prepare the tender documents and specifications of works and services to be executed during construction for obtaining further approvals from the Institute. Following buildings are proposed to be constructed in phase-II:

- 1) Classroom and Laboratory Complex - Six class room having capacity of 30 students and Nine laboratories of varying area.
- 2) Academic Amenity Complex - Two smart classrooms having capacity of 60 students, Two smart classrooms having capacity of 120 students and a library and computer center
- 3) Recreational Building – Dispensary, Shops, Canteen/cafeteria and a multipurpose hall.
- 4) Administrative Block – Hon'ble Director's Chamber, Registrar chamber and 06 Deans chamber attached with PA /staff cubical & waiting room.
- 5) As per the telephonic communication with CPWD, the Tender document along with estimated cost of the Phase – II will be submitted by CPWD latest by 03.01.2023 for further vetting. The tender will be floated next.

(iii) Status of construction work of NIT Uttarakhand – Sumari Campus

Subsequent to the signing of MoU with NBCC (India) Ltd., the Conceptual Drawings and Master Plan were submitted by NBCC (India) Ltd. vide letter No. NBCC/SBGN&U/GM2021/493, on dated 02.12.2021. These drawings along with master plan were deliberated in the 11th meeting of the Institute Level Project Monitoring Committee (ILPMC) held on 07.12.2021. After incorporating the observations, NBCC (India) Ltd. submitted the final conceptual drawings and master plan for construction of main campus of NIT Uttarakhand vide letter no. NBCC/SBG/N&U/GM/2021/518, Dated 27.12.2021. The conceptual drawings and master plan for construction was approved by the BWC in its 15th meeting on 28.02.2022.

After the approval of Conceptual Drawings and Master Plan, NBCC (India) Ltd. submitted the Detailed Project Report (DPR) to NIT Uttarakhand vide letter no. NBCC/SBG/N&U/GM/2022/294 on dated 15.07.2022 enclosed (Annexure - BWC 16.02) for the construction and development of main campus of NIT Uttarakhand at Sumari. The Detailed Project Report (DPR) was reviewed by Institute Level Project Monitoring Committee (ILPMC) in its 17th meeting held on 20.07.2022. The DPR was approved by the BWC in its 16th meeting on 28.07.2022.

Tender document along with CPM network was submitted by NBCC (India) Ltd.

on 03.09.2022. Tender was floated for engaging construction agency by NBCC (India) Ltd. on 13.10.2022. On last date for bidding i.e. 29.12.2022, three bidders have quoted. Technical evaluation is going on. Hon'ble Chairman, BoG, Director, Dean (P&D) and AD (P&D) had meeting with CMD of NBCC on 3rd Jan 2023. CMD assured tender will be open by 15th Jan 2023.
