## **SC 15.01: Reservation Roster for one post of Assistant Professor.**

Total sanction teaching positions are 86, 09 (Nine) posts for Professor, 05 (Five) for Associate Professor and 01 (One) post for Assistant Professor were marked by external ACoFAR committee.

The status of vacancies is as follows:

09 vacant posts of Professors have already been advertised for recruitment.

05 vacant posts of Associate Professor are yet to be advertised for recruitment.

01 vacant post of Assistant Professor is also to be advertised for recruitment.

Consequent upon resignation of Dr. Hemant Kumar Singhal, Assistant Professor (Grade-II), Department of Electronics Engineering and approval of the Competent Authority of NIT Uttarakhand, 01 additional post of Assistant Professor has become vacant and to be considered for the recruitment.

As per the resolution of ACoFAR Committee meeting held on dated 09.09.2022, "One vacant post may be filled at the level of Assistant Professor-Grade II (AGP 6000) in the Department of Electrical Engineering".

Therefore, Special cell is requested to deliberate upon the reservation for the vacant post of Assistant Professor which has been created due to resignation of Dr. Hemant Kumar Singhal.

**Resolution:** *The Special Cell deliberated upon the agenda item and the incumbency positions of teaching faculty (Assistant Professor), the resolution of ACoFAR Committee, the status of SC/ST/OBC/EWS categories in the Reservation Roster Register and the backlog positions as on date. Accordingly, it is recommended that the newly vacated post of Assistant Professor (Grade-II), Department of Electronics Engineering may be advertised under ST category.*


