NIT Uttarakhand participated in M.Tech. admission process for 95 sanctioned seats (Reservation as per Govt. of India Norms) through CCMT-2022. The seat matrix of CCMT-2022 is attached as **Annexure-S.32.03**. CCMT-2022 Counselling has been successfully completed on 18-08-2022. The vacant seat will cause a huge loss to the revenue of institute. The admission for self-sponsored M.Tech. Programme has been advertised on 18-08-2022 for 25 seats.
