# IMPORTANT INSTRUCTIONS FOR ELIGIBLE/PROVISIONALLY ELIGIBLE/NOT-ELIGIBLE CANDIDATES

- 1) The Institute has scrutinized the applications received within stipulated time as prescribed in the advertisement (Advt. No 10/2022 dated: 13/12/2022). The candidates found as Eligible and Provisional Eligible against the advertisement (Advt. No: 10/2022 dated: 13/12/2022) are subjected to verification of documents in original relating to their age, educational qualifications, category certificate (SC/ST/OBC/PWD/EWS), experience, Pay level/Grade pay etc. at the time of written test/screening test and interview. During actual verification of original documents, if any discrepancy is noticed, candidate will not be allowed to appear for the written test and interview.
- 2) Candidates are requested to bring a 'No-Objection Certificate' from the present employer, in case he/she is employed in a Government, Semi Government, Autonomous organization including Public Sector undertaking etc. and whose application has not been forwarded through proper channel by the employer for this post. In the absence of 'No-Objection Certificate' the candidate will not be allowed to appear for the selection process.
- 3) The candidates who have not submitted their fee receipt are instructed to bring the original fee-receipt at the time of written test and interview. SC, ST, OBC(Non-Creamy Layer) and EWS candidates should bring a valid original community certificate as per the central list issued by the competent authority. OBC-NCL and EWS certificates should be obtained on or after 01/04/2023.
- 4) If any query is there from the Not-Eligible candidates, they may also submit their representation(s) along with authentic documentary evidence from their registered email-id given in the application form on or before 18/04/2023 from the date of this notice via email to **nitukrecruitmentcell@gmail.com** with e-mail subject "NE\_Application for the Post of ......\_application number", failing which their candidature will be cancelled.
- 5) No further correspondence will be entertained after 18/04/2023 from the date of this notice.
- 6) Candidates are advised to arrive at NIT, Uttarakhand campus at least one hour prior to start of the Test/Examination, so that they do not face any difficulty in locating the Examination venue.
- 7) Candidates are not allowed to carry any personal belongings including electronic devices, mobile phones, smart watch etc. at the Examination Centre. Institute will not be responsible for safety of personal belongings of the candidates.

- 8) All shortlisted candidates for Assistant Professor Grade- II will have to appear for the Written Test & Interview and for Assistant Professor Grade-I will have to appear for Interview on the scheduled date(s) and time.
- 9) No TA/DA will be provided for appearing in the Written Test and Interview.
- 10) Candidates should make their own arrangements for stay and other logistics.
- 11) No correspondence will be entertained from candidates not considered for Written Test/Interview/Appointment.

# IMPORTANT INSTRUCTIONS TO CANDIDATES REGARDING THE ONLINE WRITTEN TEST

- 1. Medium of Test / Examination is English.
- 2. Questions will be based on syllabus for the Written Test, already notified in syllabus. Each correct answer will be awarded one (1) mark and for each wrong answer 0.25 marks will be deducted.
- 3. Each candidate must enter the examination hall minimum 30 minutes before the commencement of the examination.
- 4. Unique login id and password will be assigned to each candidate and Login to the portal 10 minutes before the commencement of the examination.
- 5. Any candidate reporting after the scheduled time of starting the examination will not be allowed strictly in the examination hall.
- 6. Each candidate must keep his/her valid Identity card (Aadhaar, Driving License, etc.,) and printout of online submitted application form while entering the examination hall.
- 7. Candidates are not allowed to carry any personal belongings including electronic devices, Bluetooth devices, mobile phones, smart watch etc.,. If anybody is caught with mobile or any electronics device during the examination and adopts any malpractices or indulges in any unfair means in examination, he/she will be debarred immediately from the examination and no request will be entertained. Also, such candidate will not be considered for any recruitment of NIT Uttarakhand in future.
- 8. The use of the programmable calculator in the examination is strictly prohibited.
- 9. The candidate has to occupy the allotted system in the examination hall. Institute will not be responsible for safety of personal belongings of the candidates
- 10. The candidate should not keep any papers, notes or other things with them. In case of doubt, invigilator can do physical frisking of the candidate.
- 11. Each candidate should carry required items for examination. A4 sheets will be given during the examination for rough work. Nobody is allowed to exchange anything (e.g. Pen, pencil, calculator, eraser, scale, etc.) in the examination hall.
