

IMPORTANT INSTRUCTIONS FOR CANDIDATES

- 1) The Institute has scrutinized the applications received within stipulated time as prescribed in the advertisement (Advt. No 15/2023 and 16/2023 dated: 10/12/2023). The candidates found as Eligible and Provisional Eligible against the advertisement (Advt. No 15/2023 and 16/2023 dated: 10/12/2023) are subjected to verification of documents in original relating to their age, educational qualifications, category certificate (SC/ST/OBC/PWD/EWS), experience, Pay level/Grade pay etc. at the time of written test/screening test and interview. During actual verification of original documents, if any discrepancy is noticed, candidate will not be allowed to appear for the written test and interview.
